This is a Release of Liability and waiver of certain legal rights. In consideration for my being permitted to participate in the activities of Freedom Mill Indoor Gun Range at the Constitutional Carry and 2nd Amendment Event Hosted by the Forsyth County Tea Party and the Forsyth County Young Republicans I agree to the following Waiver and Release:

- EYE AND EAR PROTECTION IS REQUIRED AT Freedom Mill INDOOR GUN RANGE.

- I acknowledge that shooting has inherent risks, hazards and dangers that cannot be completely eliminated.

- I UNDERSTAND THAT THESE INCLUDE BUT ARE NOT LIMITED TO:

1. The risk of handling firearms and being near others that have firearms in their possession.
2. The risk of personal injury and/or damage to personal property from shooting events.
3. The risk of personal injury from the physical requirements of shooting events.
4. The risk of possible ear damage from noise from firearms in the range.
5. The risk of possible eye damage.

- I understand that I will be required to meet and abide by any rules or requirements of the Freedom Mill Indoor Gun Range. I understand that these activities may require good physical condition and a degree of skill and knowledge. I believe that I have the physical conditioning and degree of skill and knowledge needed for me to engage in these activities safely. I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss any questions with a range officer of Freedom Mill Indoor

Gun Range. I understand that I have responsibilities and my participation in this activity is purely voluntary. I am voluntarily using the services of Country Folks Superstore Indoor Gun Range with full knowledge of the inherent risks, hazards, and dangers involved and hereby assume and accept any and all risks of injury, paralysis, or death. Lastly, I, for myself, my heirs, successors, executors, and surrogates, hereby and knowingly and intentionally waive and release, compensation and hold harmless Freedom Indoor Gun, The Forsyth County Tea Party and the Forsyth County Young Republicans including any Range staff personnel, and all range officers, agents, employees and volunteers from and against claims, liabilities, expenses (including reasonable attorney's fees), actions, and cause of action which are related to, arise out of, or are in any way connected with any participation in any activity at the Freedom Mill Indoor Gun Range at the Forsyth County Tea Party and Forsyth County Young Republicans 2nd Amendment and Constitutional Carry Event.

{If accompanied by a minor}, I being the legal guardian or parent of ("Listed Minor"), hereby agree, on behalf of the minor child, that the minor child is at least 10 years of age and will follow and adhere to the Freedom Mill GUN RANGE (hereinafter "SHOOTING RANGE") safety rules and procedures while utilizing or being present at the SHOOTING RANGE located at 2730 Spot Rd., Cumming, GA 30040. I further acknowledge the risks inherent in firearms training, firearms practice, and the use of firearms.

I, on behalf of the minor child, agree to release the SHOOTING RANGE, their agents, employees, designees and appointees from any and all manner of action and actions, cause or causes of actions, suits, damages, judgments, and claims of any kind whatsoever, in law or equity, which may result or are in any way connected or related to injuries which I may sustain while engaging in firearms training, firearms exercises, or for any activity which involves the use or discharge of a firearm.

I, on behalf of the minor child, further agree to indemnify and hold harmless, to the extent permitted by Georgia Law, the SHOOTING RANGE, their agents, employees, designees and appointees from any and all manner of action and actions, cause or causes of actions, suits damages, judgments, and claims of any kind whatsoever, in law or equity, which my spouse or another can recover for injuries which I may sustain as a result of engaging in firearms training, firearms exercises, or for any activity which I, or another, use or discharge a firearm while at the SHOOTING RANGE.

I certify that I am NOT a convicted felon and that I am not prohibited by law from being in possession of a firearm.

I certify that I am NOT currently under the influence of alcohol or drugs, prescription or otherwise.

I certify that I AM 21 years or older for the use of handguns. OR I am UNDER 21 years of age and HAVE a parent or guardian with me.

Range Safety Rules

HANDGUNS LONG GUNS All Handgun Calibers .223, 7.62x39, .308win, 300AAC, 30-30, .270win, 30-06 (NO Magnum). All Rimfire

1. ALWAYS keep firearms pointed down range and in a safe direction.
2. ALWAYS keep your finger off the trigger until ready to shoot.

3. ALWAYS keep your firearm unloaded until you are in the shooting booth and are ready to fire.
4. ALWAYS keep the action of your firearm OPEN when you are not in the firing line.
5. ALL firearms must be in the shooting booth while being used or while at rest.
6. ALL GUNS FOR RANGE MUST BE BROUGHT IN A CASE OR RANGE BAG.
7. Targets must be placed BELOW the indicated line on backers. Shots above line may incur fine.
8. No loading of firearms EXCEPT in the shooting booth.
9. No buckshots or birdshots permitted. Please use SLUGS only when shooting with a shotgun.
10. Tracer, armor piercing, incendiary, steel case, and steel core ammunition are PROHIBITED.
11. Shooters MUST ONLY use CFS purchased ammo in rental guns.
12. No one except Range Officers/Personnel can go beyond firing line at any time.
13. Eye and Ear protection are required at all times while in the shooting area.
14. NEVER consume alcohol or drugs prior to or during shooting.
15. No food, drinks, tobacco, or vaping products permitted within the range.
16. Closed toed shoes required for use of range.
17. Children must be at least 10 years of age to be allowed use of range.
18. Children under the age of 18, if shooting a long gun, or under 21 if shooting a handgun, must be accompanied by their parent or guardian and supervised at all times. PROOF OF GUARDIANSHIP IS REQUIRED.
19. Pulling gun from holster and firing is PROHIBITED.
20. Use the appropriate size target. Firing a shot on the range that results in the bullet striking anything other than the target and/or backstop, may result in damage or repair fine and/or your removal from the range.
21. ONLY shoot at your target, cross firing of targets is prohibited.
22. If you have brought more than one firearm, use only one at a time and, when finished, case the unloaded firearm and its ammunition before uncasing the next one.
23. NO flash photography is permitted on the range.
24. Pregnant or nursing mothers are not allowed on the range at any time.

- 25. Shooters may only collect their OWN brass behind the firing line (collect promptly for once Range Officers clear brass past firing line, it will not be retrievable).
- 26. The Range Master or Range Personnel reserve the right to inspect any firearms or ammunition for safety considerations.
